Financial Assistance:

Financial assistance for international students primarily comes from three sources: graduate assistantships, scholarships, and on-campus employment. Student loan programs are not available to international students. Students interested in on-campus employment should contact the Student Employment Office upon arrival at Gonzaga. A US social security card must be obtained before employment is granted. Students interested in applying for an International Student Scholarship and/or and Graduate Assistantship should complete the appropriate application form inserted in the application packet or online.

International Student Scholarships:

In the 2008-2009 academic year over 90% of eligible international students received an International Student Scholarship. These scholarships can pay for up to 50% of tuition in the fall and spring semesters. In order to be eligible an applicant must be accepted in Gonzaga's MBA or MAcc programs, have good academic standing, complete an International Student Scholarship application form, and have citizenship outside of the United States.

Graduate Assistantship for the School of Business:

Numerous international students also receive Graduate Assistantship working for the School of Business: "GA's" receive \$15 per hour and are required to work anywhere from 5-10 hours per week assisting a faculty or professional staff member. In order to be eligible for a GA, students must be registered for at least 6 credits during the semester in which the assistantship applies.

Gonzaga's TOEFL Requirements:

The TOEFL is waived for international students who have completed a baccalaureate degree from an accredited American University. An official TOEFL score of at least 88 (IBT), 230 (CPT), 570 (paper) or an IELTS score of 6.5 or above is required. Also, an interview over the phone or in person will be required. Other Programs Available to you:

Gonzaga offers an English as a Second Language (ESL) Program for those students wanting to gain English language proficiency before enrolling in a degree program. International students who achieve a score less than 570 paper or 230 computerized or 90 on the new TOEFL exam are encouraged to enroll in our ESL program. Students who complete the ESL program will still need to pass the TOEFL exam and have a personal interview. Please contact Amber McKenzie at mckenziea@gonzaga.edu for more information.
