Social discounting measures how much people are willing to share a reward with others and can be interpreted as a measure of generosity, sharing and/or altruism. When the social distance between two people increases, sharing decreases. Previous experiments have shown that the presence of another person can differentially change behavior for Japanese and US participants. In these studies, Japanese participants are generally more sensitive to changes in the social context (e.g., the implied presence of others - anonymity), relative to US participants. However, the concept of anonymity has not been compared with Japanese participants, relative to US participants during a social discounting task (i.e., sharing). Approximately 100 Gonzaga University students will be randomized into one of 3 experimental groups, based on anonymity (anonymous, observed, or standard). All participants will complete an online social discounting task, a self-construal measure, and demographic questionnaire. Social discounting (sharing) values will be compared between Gonzaga University and Meisei University students to determine if anonymity differentially affects sharing between US and Japanese participants.







7. How will data be analyzed?

Explain the methods by which data will be analyzed to achieve project aims. Once data from both Gonzaga University and Meisei University is collected, we intend to use a 2 x 3 ANOVA (country x anonymity) to test for sharing differences between countries (US vs. Japan) and anonymity conditions (Anonymous, Observed, and Standard), along with any interaction between country and anonymity condition. Country will be a between groups factor, whereas anonymity will be both a between- and within-groups factor. Significant main effects will be followed up with post-hoc t-tests. Significant interactions will be followed up with additional one-way ANOVAs for each country by anonymity condition. Demographic data will be compared using nonparametric Mann-Whitney tests for continuous measures, and binomial logistic regression tests for categorical data (e.g., alcohol use). Significant demographic differences, including independence-interdependence, will be added as covariates to create a 2 x 3 ANCOVA to determine whether any observed sharing differences can be accounted for by demographic differences between the two samples.
