# ZagLiving Application Process for On-Campus Living

The application process for returning and new students is essentially the same. There are subtle differences between those who have fulfilled the residency requirement and those who have not (exceptions will be noted). Returning residents self-select their own rooms for next academic year during the preceding spring semester (details not presented here) while new residents are assigned to a room by the Housing Office during the summer.

To begin an application, students enter ZagWeb as they normally would and click on "Enter Secure" Area.


